Indigenous Pathways brings career development and income to youth ages 14-24 who are either currently enrolled in school or want to re-enroll in a diploma or GED program. We offer a pathway in media and social media marketing (First Person Productions) and STEM education dedicated to sustainable, green energies (Green Tech Pathway). Youth are paid \$13.75 per hour for up to 60 hours over 10 weeks during afterschool 4 days a week. They may pursue an internship with a partner organization or with the Organization for contracted projects once training is complete.

4b (Code:) (Expenses \$ 129,573. including grants of \$) (Revenue \$ 100,449.) Cultural, Leadership, and Academic Support:

Afterschool, youth can partake in our virtual or in-person tutoring, cultural and educational support 4 days a week, the Native youth leadership council, and work with staff to develop quarterly Individual Educational Plans with identified goals for academic, culture connections, community engagement and well-being. We provide in-school time support with St. Paul and Minneapolis Indian Education classrooms and cultural/wellbeing groups and field trips in 4 suburban districts.

Every board member annually signs a conflict of interest disclosure form listing any potential conflicts of interest. When a potential conflict of interest does arise, that board member leaves the meeting and the remainder of the board votes on whether to proceed with the particular transaction or not.

Form 990, Part VI, Section B, Line 15a:

The Organization's Executive Committee utilizes surveys of similar positions when evaluating the compensation range for the Executive Director of the Organization. The Committee then presents the proposed salary to the complete Board of Directors for review and approval.

Top management compensation is determined through an annual review process, job description review, the Organization's budget, and the salary survey from the Minnesota Council of Nonprofits in determining compensation.
